

Transfers

The Rochester and Chelsea Extension services will meet at the Sharon Park & Ride at 8:00 AM and 5:09 PM.

- *For the morning 89er South:* Riders from the Rochester Extension service wishing to continue to the Upper Valley on the morning 89er South will need to board the Chelsea Extension bus.
- *For the afternoon 89er South:* Riders from the Upper Valley who wish to continue to Tunbridge and Chelsea will need to board the Chelsea Extension bus. The bus which picked you up in Lebanon, Hanover and White River Jct., will become the Rochester Extension when it departs the Sharon Park & Ride.

Riders may access Advance Transit at the following stops:

- The Hop
- DHMC East Entrance
- DHMC Heater Road
- DHMC Colburn Hill
- VA Hospital
- The Haven

Bus Stop Locations

- Stockbridge Park & Ride—Intersection of VT-107 & VT-100.
- Rochester Park & Ride—Across from Rochester Fire Station on north end of Rochester village (VT-100).
- Chelsea Main Street—Across from Mascoma Bank at the basketball court.
- South Royalton Park & Ride—Intersection of Chelsea Street & VT-14, across from Shell gas station.
- Tunbridge Rec. Field—In Tunbridge Village, take Strafford Road to Recreation Road. Bus stop at baseball field.

VERMONT STATE PUBLIC ACCOMMODATION LAW

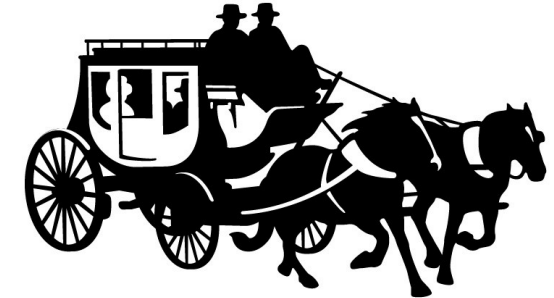
9V.S.A 4502 (a) Public accommodations states an owner or operator of a place of public accommodation or an agent or employee of such owner or operator shall not, because of the race, creed, color, national origin, marital status, sex, sexual orientation, or gender identity of any person, refuse, withhold from, or deny to that person any of the accommodations, advantages, facilities, and privileges of the place of public accommodation.
